PETTIT OIL ACCOUNT AGREEMENT

The information set forth in the account application is for the purpose of obtaining credit and is warranted to be true. I/We hereby authorize Pettit Oil to investigate all references and customary credit information sources including consumer credit reporting repositories regarding my/our credit and financial responsibility for the purpose of obtaining credit and for periodic review for the purpose of maintaining the credit relationship. The "Firm Name" name given in the Business Account Application box shall hereafter be referred to as the "Company".

CREDIT TERMS: Statements are rendered as of the last day of each month. All invoices are due in full on the 10th day of the following month or as otherwise expressly agreed. A service charge of one and one half percent (1.5% per month), or 18% per annum or the highest legal rate, whichever is less, may be assessed on delinquent invoices. Pettit Oil reserves the right to change its credit terms at any time. Applicant hereby grants Pettit Oil a security interest in product acquired from Pettit Oil to secure payment of all amounts due and to become due to Pettit Oil. New credit terms may be applied to the existing balance on your account unless prohibited by law. COD restrictions may be placed on any past due account.

CARDLOCK ACCESS CARDS: Pettit Oil operates a number of cardlock facilities through which it sells fuel utilizing automated fueling dispensers. The automated fueling dispensers are activated through access cards issued by Pettit Oil to its customers ("Access Cards"). The Access Cards also may be used to activate automated fueling dispensers operated by other distributors who participate in the same cardlock network. As the holder of Access Card(s) I/We understands that I/We may be liable for the unauthorized use of the card(s). I/We will promptly notify Pettit Oil, orally or in writing, if an Access Card is lost, stolen or being used by unauthorized persons. I/We understand that if an Access Card is given to an employee or friend, I/We authorize their use and are responsible for all charges to my/our account. I/We acknowledge that Access Cards are not credit cards and are issued for the limited purpose of activating cardlock network automatic fueling dispensers and recording the time, place, date, gallons, and cost of fuel dispensed so that the transaction can be completed by the issuance of a monthly statement to the Company/Individual.

VENUE, ATTORNEY FEES AND COST: In the event of default, and if this account is turned over to an agency and/or an attorney for collection, the undersigned agrees to pay all reasonable attorneys' fees, and/or costs of collection whether or not suit is filed. **VENUE FOR ANY ACTION ARISING OUT OF OR IN ANY WAY CONNECTED TO THIS AGREEMENT, AT PETTIT OIL'S OPTION, SHALL LIE IN PIERCE COUNTY, WASHINGTON.** APPLICANT'S SIGNATURE ATTESTS TO FINANCIAL RESPONSIBILITY, ABILITY AND WILLINGNESS TO PAY IN ACCORDANCE WITH ABOVE TERMS:
